LIABILITY LIMITATION

ALL PURCHASE ORDERS ARE ACCEPTED SUBJECT TO THE FOLLOWING CONDITIONS.

It is generally recognized that even after employing the best processing methods known to us, there still remain hazards in the field of metal finishing. As a result, and in order to avoid misunderstandings, we are setting forth below conditions under which your material will be accepted by us for processing:

1. Parts, materials, etc. as processed by us shall be presumed to be accepted as satisfactory by you if we are not notified of damages, shortages, or other discrepancies within 10 days of shipment date.
2. If your parts are not finished correctly or are damaged while in our possession, one of the following will apply:
 - a. If the part can, in our opinion, be reworked by us so that the finish will be as you specified, our only liability is for the cost of reworking the part.
 - b. If the part cannot, in our opinion, be reworked by us so that the finish will be as you specified, our liability for any cause is limited to twice the amount of our charges for the work done on any material (first to compensate for the charges and second to compensate in the amount of the charges). Charges for our services are based on this policy limiting our liability.
3. Liability greater than that outlined in paragraph (2) above will be assumed by us only when so agreed in writing and signed by an officer (not a representative) of Palmetto Plating Co., Inc. In such event, a higher charge may be made for our services.
4. Rejected parts must be returned to us for a rework. Further processing, assembling, painting, or other work prior to such rejection shall constitute a waiver of any liability on the part of Palmetto Plating Co., Inc.
5. Where operations or processes performed by us are in the nature of "salvaging" parts or material, the work is accepted on a "best effort" basis and no liability shall be attached to us unless previously agreed upon in writing and signed by an officer (not a representative) of Palmetto Plating Co., Inc. prior to processing the job.

No agent or representative is authorized to alter the above conditions, except in writing and duly signed by an officer or Palmetto Plating Co., Inc.

We are sure you will agree with us that the conditions above are realistic and reasonable and that acceptance of the material for processing subject to such conditions will permit us to continue to provide quality metal finishing at an economical price.

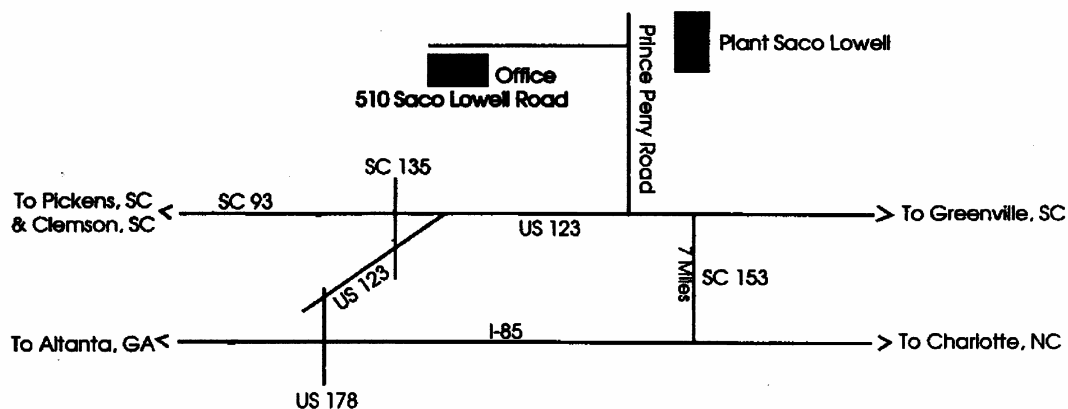
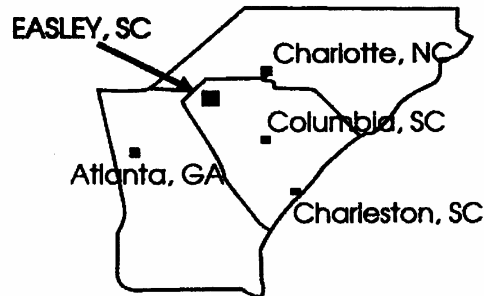

From I-85, take Exit number 40 and go right on SC-153 for 7 miles to intersection with US-123. Exit toward Easley. At the **3rd** traffic light, turn right and go 0.1 miles on Prince Perry Road, turn left on Saco-Lowell Road, go 0.7 miles – Main Office and Plant is on the left.

Traveling North on I-85 (from Atlanta, GA or Anderson, SC)
From I-85, take US-178 to US-123, turn right in US-123 toward Easley. At Easley, go to the 7th traffic light, turn left and go 0.1 miles on Prince Perry Road, turn left on Saco-Lowell Road, go 0.7 miles – Main Office and Plant is on the left.
